







Statewide Hospitalized Covid Data taken from Tele Tracking On November 9, in MN, there were 7673 people hospitalized and 740 of them in the ICU and 465 on vents. Of those in **the hospital 1224 were Covid patients and 249 of those were in ICU and 135 of them on vents**. This means that **15.95** % **of the Hospitalized have Covid and 33.658% of the ICU capacity** is from Covid patient. Of the 1224 total Covid patients 18 are categorized as pediatric.

State Healthcare Coordination Center

- The SHCC is a MDH and MHA supported entity that is part of the State Emergency Operation Center (SEOC) and is responsible for:
 - Long Term Care support testing, urgent staffing and PPE distribution and training
 - Auxiliary Care Site and Fatality Management System with national guard have prepared a recently vacate Long Term care site for med surg level of care should it be needed as well as a former produce storage facility for fatality management
 - PPE Distribution by request to long term or acute care through SEOC and national guard
 - Critical Care Coordination Center (C4)

SHCC Critical Care Coordination Center (C4)

Goal:

- To create and enhance visibility and coordination for patient placement from ED to ICU or ICU to ICU to available staffed ICU beds with ventilators if necessary across Minnesota during the COVID-19 surge with:
 - 24/7 connection to a team who can coordinate and assist with information and resources for bed placement, transportation and critical care conversations
 - Use MnTrac available technology to provide visibility for decision making including recent patient status R/Y/G
 - Assist to optimize health system teams, structures and systems in working with C4

What does the Critical Care Coordination Center do

- Provides Visibility to available staffed ICU beds and ventilators to C4 with MnTrac, HHS submissions and C4 ICU bed huddle
- Process defined for potential patient movement between hospitals with staffed ICU beds
- If normal operations do not result in finding a bed:
 - Assistance with connection to sites with available staffed ICU Beds
 - Coordination to assist with load leveling and balancing of available state critical care resources by geographic region
 - Access to Critical Care EMS resources for transportation
 - Provide access to critical care consultation if resources not immediately available

Who is the C4?

- In July 2020 the state of Minnesota contracted with MHealth Fairview and their system operations center to "run" the C4
- They operate as an entity of the MDH in a contract extension state administered for the Regional Ebola Assessment and Treatment Center designation that MHealth Holds with the CDC and received federal funding for.
- Dr Karyn Baum and Mary Jo Huppert are the VPs accountable for the SOC and the C4.
 there is 24/7 hospitalist support
- The C4 Oversite and Policy group with members from MHA (Fairview, Allina, North, Northfield and Centracare) the SHCC and the MDH meet weekly to review calls, see data discuss the current and future state and provide collaborative direction
- The C4 runs ICU capacity calls at minimum 1x per week but can be 7 days per week if needed based on crisis standards of care
- Access to Intensivists from many of the large health systems to provide consultation and type of bed needed for hospitals in greater Minnesota without access to those services through the Critical Care Physicians workgroup (SHCC)

How do I call C4 when I need an ICU bed?

 If you are part of a system – determine your internal system for calling C4 – at Allina we call our access center and they will call C4 for us.
 Your system may decide that you should call directly

 If you are not part of a system and need an ICU bed and know there are no available beds using your usual system call the C4 directly






